FREE RANGE HEALTH SERVES LOW-INCOME SENIORS BY PROVIDING AFFORDABLE ACUPUNCTURE AND EAST ASIAN MEDICINE SERVICES AT SENIOR CENTERS ACROSS SNOHOMISH COUNTY, WA. IN 2018, THESE SENIOR CENTERS INCLUDED: THE LYNNWOOD SENIOR CENTER, THE STILLAGUAMISH SENIOR CENTER, AND THE SNOHOMISH SENIOR CENTER. THE MAJORITY OF OUR PATIENTS ARE OVER THE AGE OF 65 AND REPORT ANNUAL HOUSEHOLD INCOMES OF LESS THAN \$20,000.
